The information in this Selection Policy is accurate as at 31 March 2025 but remains subject to change. As a result of the unique and extenuating circumstances caused by the late confirmation of Glasgow as hosts for the 2026 Games and the consequential outstanding Commonwealth Games Federation (CGF) requirements, Commonwealth Games Scotland (CGS) and **scottish**athletics will be closely monitoring this Selection Policy to determine if any changes are necessary.

- 1. For the avoidance of doubt, CGS reserves the right to amend this Selection Policy in any manner, and in the sole and absolute discretion of CGS, should CGS consider that qualification process would be fairer having regard to the interests of all athletes and the prevailing circumstances.
- 2. In addition, CGS and **scottish**athletics reserve the right to not apply any aspect of this Selection Policy when making any decision, if in the sole and absolute discretion of CGS, it would, as judged by CGS, be unfair or unreasonable.

#### INTRODUCTION

- This selection policy has been agreed by scottishathletics and CGS. It provides detail
  on the process by which scottishathletics will arrive at athlete nominations, which will
  be submitted to CGS for consideration, for final selection to Team Scotland for
  Glasgow 2026.
- 4. Achievement, by an athlete, of individual selection standards detailed in this document, is therefore the first step by which nomination can be considered. The final decision in selection to the 2026 Games lies with CGS.
- 5. **scottish**athletics will nominate only those athletes that have qualified under both the Athletics Specific Selection Standards stated below, and the CGS General Selection Policy (available on the <u>CGS website</u>) that should be read in conjunction with these standards.
- 6. Entry numbers per event and the overall number of athletes are in accordance with CGF allocation and should more athletes achieve the standards then **scottish**athletics will prioritise in accordance with this policy.

#### **SELECTION AIM**

- 7. To select a team of athletes capable of competing with distinction for Scotland at the 2026 Commonwealth Games, and collectively:
  - Having a higher percentage of athletes meeting the general selection standards when in competition at these Games than in 2022.
  - Meeting the stated performance aims of each sport at the Games.
  - Team members having a positive experience within Team Scotland at the Games.
- 8. This Policy is consistent with this aim and will focus on:
  - Maximising medals at the 2026 Games.
  - Maximising top 6 placings at the 2026 Games.
  - Preparing athletes to deliver world class performances at the 2030 Commonwealth Games and beyond.

#### **ELIGIBILITY & CONDITIONS FOR REPRESENTATION**

- 9. Athlete eligibility and conditions for representing Scotland will be as outlined in the CGF Constitution and Byelaws. Please see Appendix 1 for the current eligibility Byelaw. Should these change, the most recent version will be used.
  - 9.1 Where prospective team members do not automatically comply with the above, they will only be nominated for final selection if they receive prior approval from the CGF under their guidelines.
  - 9.2 For the avoidance of any doubt and as agreed by UKA, CGF and the Home Nations Commonwealth Games Associations, where the 2026 Games are concerned Home Nation athlete eligibility on grounds of birth will be based on the nationality of the athlete, the athlete's parents or the athlete's grandparents.

### ATHLETICS SPORT SPECIFIC SELECTION STANDARDS

#### 10. Qualification Period

To be considered as part of the nomination process, athletes must achieve **one** of the Selection Standards below within the following qualification period:

- 12. Achievement of the Selection Standards shall not result in automatic nomination to CGS.
- 13. The maximum number of athletes selected by any country for each individual event is three (3).
- 14. Where more than three athletes attain the Selection Standards in an individual event then athletes will be selected for nomination based on consideration of the criteria as outlined in the relevant rounds of Phase 2 (paragraph 50).
- 15. In the event that the number of athletes achieving the Selection Standards exceeds the number of athletics team places available, then athletes will be selected for nomination based on consideration of the criteria as outlined in the relevant rounds of Phase 2 (paragraph 50).

### Relay Teams

- 16. The maximum number of Relay Teams ("Team(s)") nominated for each relay event shall be one (1).
- 17. A Team may be considered for nomination based on any of the following three conditions (not listed in order of priority):
  - 17.1 The selection standard for the relay (paragraph 1) is achieved or;
  - 17.2 All athletes meet the selection criteria for individual events or;
  - 17.3 Two or more athletes meet the selection criteria for individual events and the addition of further athletes\* indicates that the Team could achieve a performance which meets the aims of this Policy.
- 18. With reference to the conditions outlined under paragraph 17.1 and 17.3, should a Team be under consideration for nomination, the minimum pool of athletes shall be five (5).
- 19. For the avoidance of doubt, the athletes who are members of a Team that has met the Selection Standards shall not be automatically selected for the Nominated Team. Each individual who shall form the Nominated Team(s) shall be separately selected on merit with reference to the nomination criteria (paragraph 50).
- 20. Individual athletes, forming a Team, who do not individually meet the Selection Standards shall only be considered as part of a relay pool if there is evidence that their contribution to the Nominated Team could achieve a performance that meets the aims of this Policy.
- 21. Nominations for Teams will take place during Phase 2 and will be prioritised in line with the aims of this Policy and the criteria outlined in paragraph 50.
- 22. Given the restricted number of allocated places available, a scenario where four (4) or more athletes have achieved individual Selection Standards will increase the likelihood of a team being considered during round 2 or round 3 of the Phase 2 selection.

#### OTHER FACTORS FOR CONSIDERATION

23. All nominated athletes must have completed the required anti-doping education.

#### Performance Considerations

- 24. Performances must be achieved during competitions organised or authorised by World Athletics, its Area Associations or its National Member Federations. Thus, results achieved at university or school competitions must be certified by the National Federation of the country in which the competition was organised.
- 25. UK domestic competition performances will only be recognised if they are achieved in a UKA Level 2 licensed competition or higher (see <a href="https://www.uka.org.uk/competitions/fixtures/">www.uka.org.uk/competitions/fixtures/</a> for details on the UKA competition licenses.
- 26. Multiple performances achieved in the same individual event in a single day at an official Championship of UK national level or higher will only count as follows:
  - In a track event best time in each round within the day.
  - In a field event only the best mark in the final and best mark in the pool.
- 27. Performances otherwise achieved in the same individual event in a single day will count as follows:
  - In track events, only the fastest legal result of the day;
  - In throwing events, only the best performance of the first competition of the day;
  - In horizontal jumps, only the best performance of the first competition of the day, unless every mark achieved by the athlete was wind-assisted in which case the best trial in a second competition held under non-wind-assisted conditions will count.
- 28. Performances achieved in mixed events (in stadia) between male and female participants shall not be considered.
- 29. Performances in mixed gender 10k road events will be considered on courses certified by the National Federation of the country in which the competition was organised.
- 30. In the throwing events, no performance will be considered if it is achieved in a mixed age group competition where lighter weight implements are in the same pool.
- 31. Wind-assisted performances (or performances achieved at events where wind measurement was not available) for events held completely in a stadium will not be considered. (see World Athletics rules 260.14(c), 260.17 (b) and 260.18).
- 32. For combined events, the conditions set in World Athletics rule 11.4 (or any revised or amended rule relating to wind readings in combined events in force at the time) will be applied for qualification purposes. This requires one of the following conditions to be satisfied:
  - The wind velocity in any individual event shall not exceed plus 4 metres per second; or
  - The average wind velocity (based on the algebraic sum of the wind velocities, as measured for each individual event, divided by the number of such events) shall not exceed plus 2 m/s.

- 33. Hand-timed performances in 100m, 200m, 400m, 110/100m hurdles, 400m hurdles and 4x100m relay will not be considered.
- 34. A fully approved automatic timing device must be used in all track events up to and including 400m. Failure do so will render a result invalid for consideration.
- 35. In endurance events of 800m and longer, where automatic timing has been compromised, hand times shall be considered. In these exceptional circumstances the performance must have been timed by three timekeepers each of whom should be Level 4 Technical Officials.
- 36.100m, 200m, 400m, 110m/100m hurdles, 400m hurdles performances at altitudes of above 950m will not be considered.
- 37. Indoor performances will be considered for all appropriate field events and for individual track events with a distance of 200m and above.
- 38. Indoor performances must be set on a standard 200m indoor track.

#### SELECTION PROCESS

- 39. The primary consideration in nominating any athlete for selection will be their outdoor performance(s) achieved during the Qualification Period.
- 40. However, at the sole discretion of **scottish**athletics Selection Panel, athletes who, in **scottish**athletics' opinion, represent a very strong medal prospect but due to exceptional circumstances have been unable to perform to the best of their ability during the Qualification Period may be considered for nomination subject to proving form and fitness (with reference to paragraph 51) to the satisfaction of the **scottish**athletics Selection Panel prior to the end of the Qualification Period.
- 41. Where an athlete attains the Selection Standards in more than one event, prior to the selection meeting, they will be asked to confirm the event(s) in which they wish to be considered for nomination. Priority event(s), where relevant, will then be agreed with the athlete prior to the start of the athletics programme at the 2026 Games.
- 42. Where an athlete has attained the Selection Standard in one *individual* event, they may still be nominated for a second event at the sole discretion of the Selection Panel. Priority event(s) will then be agreed with the athlete prior to the start of the athletics programme at the 2026 Games.
- 43. Where an athlete has subsequently been entered for more than one event the final decision on any additional events the athlete competes in lies with the athlete and Team Scotland Athletics Team Management in Glasgow, taking account their priority event(s) (as outlined above), the event schedule, selection priorities and local 2026 Games factors.
- 44. Final selection to the 2026 Games team is dependent on the provision of relevant information required by CGS such as completion and signing of the CGF Eligibility form and CGS Team Member Agreement.

#### 45. Selection Panel

- 45.1 Nominations will be made by the **scottish**athletics Selection Panel which shall be comprised by the following individuals:
  - **scottish**athletics President (Chair of Selectors casting vote only)
  - scottishathletics Head of Performance (voting)
  - Convenor Track & Field Commission (voting)
  - CGS Representative (monitoring role, non-voting)
  - Independent Panel Member (non-voting)
- 45.2 At the discretion of the Chair of Selectors, where appropriate, additional non-voting attendees with relevant expertise may be invited to attend.
- 45.3 In the event of an actual, potential, or possible conflict relating to any voting member of the Panel, it should be reported to the Chair of Selectors of the selection meeting who shall determine whether the voting member in question should be permitted to take part in relation to any selection decision(s). The Chair of Selectors may appoint an alternative voting member if necessary.

#### 46. Nomination and Selection Timeline

Nominations will be submitted to CGS by **scottish**athletics in two phases as outlined in the table below.

47. Due to time and logistical constraints, it is not possible for **scottish**athletics to contact all athletes who have not been nominated. If an athlete has not been notified by 10:00 Tuesday 9 June, they have not been nominated. There is no obligation on **scottish**athletics to notify of non-nomination.

#### 48. Phase 1:

- 48.1 Athletes may be nominated in Phase 1, and without achieving the Selection Standard, provided they:
  - Finish in the top 12 at the Tokyo World Championships; and
  - Have agreed to prioritise the Glasgow 2026 Commonwealth Games; and
  - Meet all other selection criteria as outlined in this policy.
- 48.2 A maximum of 2 athletes per event may be nominated in Phase 1.
  - Athletes will only be nominated in the athletics event in which they have finished top 12 at the Tokyo World Championships.
  - Phase 1 selections will be ratified during round 1 of the Phase 2 selection meeting.
  - All pre-selected athletes will be expected to demonstrate, to the satisfaction of the Selection Panel, satisfactory form and fitness between the 1 April – 7 June 2026 which suggests that they are capable of producing a performance at the 2026 Games which meets the aims of this Policy.
  - For the avoidance of doubt, there is no requirement to nominate any athletes in Phase 1 if the criteria summarised above and detailed throughout this policy are not met.

#### 49. Phase 2

- 49.1 In Phase 2, the Selection Panel will nominate eligible athletes for the remaining allocated places provided they have:
  - Achieved at least one of the Selection Standards by the end of the Qualification Period;
  - Met all other relevant selection criteria as outlined in this Policy.
- 49.2 In Phase 2, remaining places will be allocated on a priority basis in the rounds outlined below:
  - Round 1 Confirm form and fitness of athletes selected in Phase 1 (paragraph 48)
  - Round 2 Medal Zone Athletes & Relay Teams
  - Round 3 Top 6 Zone Athletes & Relay Teams

- 50. In deciding nominations, the Selection Panel shall consider a combination of the following criteria as well as any other factors that may be deemed relevant to achieving the aims of this Policy. The following criteria is not listed in any order of preference. It may be given unequal weight to best meet the performance aims of this Policy.
  - 50.1 The achievement of the Selection Standard(s) in accordance with paragraphs 10-22 and the performance considerations outlined in paragraphs 24-38 of this policy.
  - 50.2 World Athletics 2025 & 2026 Top Lists (at 3 Per Country)
  - 50.3 Commonwealth 2025 & 2026 Top Lists (at 3 Per Country)
  - 50.4 Previous major competition history
  - 50.5 Current form and performance consistency
  - 50.6 Head-to-heads, within the relevant Qualification Period
  - 50.7 Injury/illness status
  - 50.8 Any other factors that the Selection Panel deem relevant

## In addition to the criteria above, the following apply to relay only

- 50.9 Impact on the number of overall allocated places
- 50.10 The number of athletes meeting individual Selection Standards
- 50.11 Specific relay skills including but not limited to: adaptability, ability to execute a particular leg, flat speed, check mark discipline; consistency of performance in key relay elements as determined by the Panel
- 50.12 Season's best and position in season Top Lists (3 per nation)
- 50.13 Head-to-heads with other relevant athletes
- 50.14 Impact on medal winning potential in relay teams
- 50.15 Contribution and commitment to relay team-based training / competition activity
- 50.16 Any other factors that the Selection Panel deem relevant

#### 51. Form & Fitness:

Supporting evidence shall be provided to the Selection Panel, to support nominations, including (but not limited to) information and data from:

- Competition and training
- scottishathletics Head of Performance
- The relevant scottishathletics Performance Team Member
- The relevant Medical/ Support Staff (to include any relevant information on ongoing or recurring injuries and illnesses that may impact performance).
- 52. Athletes who have not been nominated to CGS by the **scottish**athletics Selection Panel may appeal against their non-nomination (paragraph 59).
- 53. Once finalised, nominations will be forwarded from **scottish**athletics to CGS, who has the final responsibility for team selection.

#### **DE-SELECTION**

## 54. Antidoping

Athletes suspended by their Governing Body as a result of ongoing or concluded anti-doping violation allegations, will not be considered for nomination or selection, and if previously selected will be de-selected from the Glasgow 2026 team.

## 55. Injury/ Illness Management

Where injury issues, or illness, are identified at or after selection, a fitness test may be used to determine that the athlete is capable of performing to the level that they were selected for the Games. The format will be determined by CGS after discussion with the Athletics Team Management. This will be specific to Athletics and the athlete's condition and may include input from CGS medical staff. Any selection or deselection decision, following such a test, will be made by CGS after discussion with the Athletics Team Management and will be final.

56. Athletes in breach of CGS policies, code of conduct and/or team agreements and/or any other rule or regulation may be removed from the pool of athlete nominations.

#### **APPEAL PROCESS**

## Appeals against non-nomination to CGS (athletes to scottishathletics)

- 57. Following the meeting of the Selection Panel, the **scottish**athletics Head of Performance (or other nominated **scottish**athletics person) will contact all nominated athletes.
- 58. In the event an athlete wishes to appeal their non-nomination, they should carefully note the grounds for appeal and the deadlines as set out in this policy.
- 59. The sole grounds of appeal against the decision of the Selection Panel will be restricted to one of the following:
  - 59.1 there has been a failure to follow and apply the content of this Policy; or
  - 59.2 the Selection Panel has come to a decision on the basis of an error of fact and had the accurate information been considered/provided no other selection panel acting with reasonable care would have come to the same decision as the Selection Panel.

The right to appeal a nomination decision is permitted on these limited grounds only and must not be seen as an opportunity to dispute the opinion of the Selection Panel where the proper procedure outlined in this Policy has been followed and considered. In reaching its decision the Selection Panel are acting as experts in their field and the athletes agree that in so doing the panel exercises judgment and discretion based on its expert opinion which is not in itself capable of challenge.

60. The 'Notice of Appeal' (appeal) must be received in writing (by email) and be submitted to, and received by, the **scottish**athletics Chief Executive Officer (CEO) email <a href="mailto:colin.hutchison@scottishathletics.org.uk">colin.hutchison@scottishathletics.org.uk</a> by 10:00 on Thursday 11 June. Any appeal received after the stated time and date shall be marked as out of time and not considered any further.

- 61. The appeal shall contain full details of the name, address and date of birth of the athlete and must outline in full the grounds of appeal upon which the athlete wishes to rely upon with reference to paragraph 59 above.
- 62. Appeals will be heard by the **scottish**athletics Appeals Panel.
- 63. The Appeals Panel will be made up of three representatives from **scottish**athletics who were not involved in the initial selection process: CEO; Board member and a member of **scottish**athletics with no conflict of interest.
  - 63.1 The panel will meet to consider any appeals on Thursday 11 June 2026
- 64. Should the **scottish**athletics Appeals Panel uphold any athlete appeal(s) they will refer the matter to the Selection Panel for reconsideration. It is anticipated that the Selection Panel may, in the case of a cap/limit to Team numbers, require to consider afresh the selection/nomination of other athletes as a result of any successful appeals.
- 65. All appeal decisions will be communicated to the athlete(s) within 24 hours.

## Appeals against non-selection of athletes by CGS (scottishathletics to CGS)

- 66. **scottish**athletics will also have the opportunity to appeal to CGS if athletes that it has nominated are not subsequently selected by CGS.
- 67. Individuals do not have the right to appeal directly to CGS nor do they have the right to oblige **scottish**athletics to appeal to CGS. The decision as to whether to appeal or not is at the sole and unfettered discretion of **scottish**athletics.
- 68. All CGS appeal decisions will be made ahead of a final announcement of the 2026 Games Team.
- 69. If an appeal is submitted to CGS by **scottish**athletics, a CGS Appeal Panel will consider the case along with any additional information provided.
- 70. The appeal must be made by **scottish**athletics by email to <a href="mailto:jon.doig@teamscotland.scot">jon.doig@teamscotland.scot</a> within 24 hours of notification of selection outcomes by CGS.

72. CGS and **scottish**athletics reserves the right at any time to amend, in their sole discretion, this Policy and will make any amended version publicly available on the CGS and **scottish**athletics websites.

## **APPOINTMENT OF TEAM STAFF**

73. A Team Manager will be appointed by CGS in consultation with **scottish**athletics by July 2025. The final complement of Athletics team staff attending the Games will ultimately depend upon team numbers and composition and will be determined by CGS in consultation with **scottish**athletics. This will include different categories of accreditation and access to the Games accommodation and other secure areas.

- 6. Entry numbers per event and the overall number of athletes are in accordance with CGF allocation.

## Additional Sport Specific Eligibility

- 10. To be eligible for selection an athlete must:
  - Be internationally classified with a confirmed sport class status or review with a fixed review date of 2027 or later as of the sport entries deadline of 23 June 2026;
  - Hold an active World Para Athletics (WPA) Licence for the 2026 season;
  - Have achieved a valid result in at least one (1) WPA Recognised Competition
    within the qualification period outlined in paragraph 11 of this policy (in
    accordance with the WPA Athlete Licensing Programme Policies valid for the
    2025-2026 seasons) in the event(s) in which they intend to compete;
  - Not be under a current disqualification or suspension by the CGF, or their respective Affiliated CGA or WPA or under the World Anti-Doping Code:
  - Have complied with all applicable rules and regulations of the CGF, WPA and the World Anti- Doping Code as may be modified and applied by the CGF to ensure that the overriding principles of the Commonwealth Games are observed;
  - Have met the CGF's eligibility regulations in accordance with the CGF Constitution:
  - Have complied with the minimum age regulations as stipulated by WPA;
  - WPA and CGF may consider any valid, personal, and or extenuating circumstances for not being compliant with the above eligibility requirements. All decisions made by WPA and CGF are final with no opportunity for protest or appeal;
  - WPA and CGF may consider and take into account, at its sole discretion, any
    personal and/or extenuating circumstances for an athlete having not satisfied
    both scottishathletics and CGF's eligibility criteria. All such decisions made by
    WPA and CGF are final with no opportunity for protest or appeal.

- 16. The WPA World Rankings will be used to allocate seven slots per medal event (paragraph 12).
  - 16.1 In the first instance, up to 2 athletes per CGA can qualify for a Direct Qualification slot per event. Should there be no further eligible athletes on the WPA Commonwealth Rankings, then CGAs with the highest ranked third athlete will be eligible to receive a third Direct Qualification slot per event.
  - 16.2 In all circumstances, the maximum number of athletes that can be selected by any country for each event will be three (3).
  - 16.1 Receipt of an invitation is not a guarantee of automatic selection.

#### 17. Selection Panel

- 17.1 Nominations will be made by the **scottish**athletics Selection Panel which shall comprise of the following individuals:
  - scottishathletics President (Chair of Selectors casting vote only)
  - scottishathletics Head of Performance (voting)
  - Convenor Track & Field Commission (voting)
  - CGS Representative (monitoring role, non-voting)
  - Independent Panel Member (non-voting)
- 17.2 At the discretion of the Chair of Selectors, where appropriate, additional non-voting attendees with relevant expertise may be invited to attend.
- 17.3 In the event of an actual, potential, or possible conflict relating to any voting member of the Panel, it should be reported to the Chair of Selectors of the selection meeting who shall determine whether the voting member in question should be permitted to take part in relation to any selection decision(s). The Chair of Selectors may appoint an alternative voting member if necessary.
- 18. In deciding nominations, the Selection Panel shall consider a combination of the following criteria as well as any other factors that may be deemed relevant to achieving the aims of this Policy. The following criteria is not listed in any order of preference. It may be given unequal weight to best meet the performance aims of this Policy.
  - Performance in the Qualification Period in relation to the 3<sup>rd</sup> highest ranked WPA performance
  - WPA Ranking
  - Commonwealth Ranking
  - Current form and performance consistency
  - Future individual medal potential at major events
  - Previous major competition history
  - Injury/illness status
- 19. Any re-allocation slot invitations will be forwarded to **scottish**athletics from CGS. In deciding nominations, the Selection Panel will follow the same process as outlined in paragraph 18.

#### 20. Form and Fitness

- 20.1 All selected athletes shall be expected to demonstrate, to the satisfaction of the Selection Panel, satisfactory form and fitness between the 1 April 7 June 2026 which suggests that they are capable of producing a performance at the 2026 Games which meets the aims of this Policy.
- 20.2 Supporting evidence shall include (but shall not be limited to) information and data from:
  - Competition and training
  - scottishathletics Head of Performance
  - The relevant scottishathletics Performance point of contact and
  - The relevant Medical/ Support Staff
- 21. Athletes who have not been nominated by the **scottish**athletics Selection Panel to CGS may appeal against their non-nomination (paragraph 29).
- 22. Final selection to the 2026 Games team is dependent on provision of relevant information required by CGS such as completion and signing of the CGF Eligibility form and CGS Team Member Agreement.
- 23. All nominated athletes must have completed all required anti-doping education.

#### **DESELECTION**

#### 24. Anti-doping

Athletes suspended by their governing body as a result of ongoing or concluded anti-doping violation allegations, will not be considered for nomination or selection, and if previously selected, will be deselected from Team Scotland 2026.

#### 25. Injury/ Illness Management

Where injury issues, or illness, are identified at or after selection, a fitness test may be used to determine that the athlete is capable of performing to the level that they were selected for the 2026 Games. The format will be determined by CGS after discussion with the Athletics Team Management. This will be specific to Athletics and the athlete's condition and may include input from CGS medical staff. Any selection or de-selection decision, following such a test, will be made by CGS after discussion with the Athletics Team Management and will be final.

26. Athletes in breach of CGS policies, code of conduct and team agreement may be de-selected.

## **APPEAL PROCESS**

## Appeals against non-nomination to CGS (athletes to scottishathletics)

- 27. Following the selection meeting, the **scottish**athletics Head of Performance (or other nominated **scottish**athletics representative) will contact all nominated athletes.
- 28. In the event an athlete wishes to appeal their non-nomination, they should carefully note the grounds for appeal and the deadlines as set out in this Policy.

- 29. The sole grounds of appeal against the decision of the selection panel (45) will be restricted to one of the following:
  - 29.1 there has been a failure to follow and apply the content of this Policy; or
  - 29.2 the Selection Panel has come to a decision on the basis of an error of fact and had the accurate information been considered/provided no other selection panel acting with reasonable care would have come to the same decision as the Selection Panel.

The right to appeal a nomination decision is permitted on these limited grounds only and must not be seen as an opportunity to dispute the opinion of the Selection Panel where the proper procedure outlined in this Policy has been followed and considered. In reaching its decision the Selection Panel are acting as experts in their field and the athletes agree that in so doing the panel exercises judgment and discretion based on its expert opinion which is not in itself capable of challenge.

- 30. The 'Notice of Appeal' (appeal) must be received in writing (by email) and be submitted to, and received by, the **scottish**athletics Chief Executive Officer (CEO) email <a href="mailto:colin.hutchison@scottishathletics.org.uk">colin.hutchison@scottishathletics.org.uk</a>, by 23:59 on 08 April 2026 (within 24 hrs of communication of non-nomination of re-allocation slot(s)). Any appeal received after the stated time and date shall be marked as out of time and not considered any further.
- 31. The appeal shall contain full details of the name, address and date of birth of the athlete and must outline in full the grounds (paragraph 29) upon which the appeal is being made.
- 32. Appeals will be heard by the **scottish**athletics Appeals Panel.
- 33. The Appeals Panel will be made up of three representatives from **scottish**athletics who were not involved in the initial selection process: CEO; Board member and a member of **scottish**athletics with no conflict of interest.
  - 33.1 This panel will meet to consider any appeals by Wednesday 9 April 2026 (within 24 hrs of communication of non-nomination of re-allocation slot(s))
- 34. Should the **scottish**athletics Appeals Panel uphold any athlete appeal(s) they will refer the matter to the selection panel for reconsideration. It is anticipated that the Selection Panel may, in the case of a cap/limit to Team numbers, require to consider afresh the selection/nomination of other athletes as a result of any successful appeals.
- 35. Where an appeal is not upheld, the decision will be communicated back to the athlete(s) within 24 hours.

## Appeals against non-selection of athletes by CGS (scottishathletics to CGS)

- 36. **scottish**athletics will also have the opportunity to appeal to CGS if athletes that it has nominated are not subsequently selected by CGS.
- 37. Individuals do not have the right to appeal directly to CGS nor do they have the right to oblige **scottish**athletics to appeal to CGS. The decision as to whether to appeal or not is at the sole and unfettered discretion of **scottish**athletics.

- 38. All CGS appeal decisions will be made ahead of a final announcement of the 2026 Games Team.
- 39. If an appeal is submitted to CGS by **scottish**athletics, a CGS Appeal Panel will consider the case along with any additional information provided.
- 40. The appeal must be made by **scottish**athletics by email to <a href="mailto:jon.doig@teamscotland.scot">jon.doig@teamscotland.scot</a> within 24 hours of notification of selection outcomes by CGS.
- 41. Appeal dates for any athlete involved in the re-allocation slot process are detailed in brackets listed in the relevant points above.

#### APPENDIX 1 – CGF BYELAW 17

#### 1. ELIGIBILITY

**1.1.** It is the responsibility of all Affiliated CGAs to ensure that their competitors are fully aware of and comply with Byelaw 17.

#### 2. PRIMACY

- **2.1.** Subject to Byelaw 17(4) 17(5) 17(6) and 17(7), a competitor shall be eligible to represent the Commonwealth Country which enters them where they satisfy at least one of the following requirements:
  - a) Are in possession of a current valid passport of the Commonwealth Country which enters them, or:
  - b) Are a subject who can demonstrate 'Belonger Status' in Great Britain or relevant British Overseas Territory of the Commonwealth Country which enters them.
  - c) In respect of the following Affiliated CGAs: -
  - i. Guernsey, Jersey, and Isle of Man. The governments of these three Crown Dependencies do not define citizenship. For these Affiliated CGAs, citizenship shall be defined as three (3) years continuous residency immediately prior to the Commonwealth Games. For the avoidance of doubt, the immediately prior threeyear period shall mean the three-year period that immediately precedes the "final entries deadline"\* date of the relevant Games as determined by the respective Organising Committee ("Continuous Residency") and the competitor must be in possession of a current valid UK passport.
  - ii. Northern Ireland. Byelaw 17 will defer to the Belfast Agreement (1998). Northern Ireland athletes who meet birth right criteria are to be treated equally regardless of their possession of either a current valid UK or Irish passport (but must hold one of these). This right is enshrined within the Constitution Issues (iv) of the 1998 Belfast Agreement.
  - iii. Norfolk Island. Any individual who was in possession of a current valid New Zealand passport and was also deemed eligible to compete at the Gold Coast 2018 Commonwealth Games for Norfolk Islands may continue to compete for Norfolk Islands at future iterations of the Games.

#### SECONDARY

- 3.1. Subject to Byelaw 17(4) 17(5) 17(6) and 17(7), where a competitor was born in a Commonwealth Country which has common citizenship/passport with other Commonwealth Countries, the competitor may represent either:
  - a) the Commonwealth Country of their birth; or
  - b) the Commonwealth Country of birth of their parent; or
  - c) where the relevant IF recognises grandparents as part of its eligibility criteria, the competitor may represent the Commonwealth Country of birth of their grandparent; or
  - d) the Commonwealth Country where they have completed a minimum period of three (3) years continuous residency immediately prior to the Commonwealth Games. For the avoidance of doubt, the immediately prior three-year period shall mean the three-year period that immediately precedes the "final entries deadline"\* of the relevant Games as determined by the respective Organising Committee.

- 3.2. Subject to the other provisions of this Byelaw 17, where a competitor is eligible to represent more than one Affiliated CGA due to common passport privileges they may choose which Affiliated CGA to represent. For the avoidance of doubt, if an individual has competed at a Commonwealth Youth Games this will not be deemed to be a choice of country, and the competitor may choose to represent a different Affiliated CGA at a Commonwealth Games.
- 3.3. For the avoidance of doubt subject to Byelaw 17(4) and 17(5) any competitor of a common passport area who competes for their common passport country (i.e. Great Britain, New Zealand and Australia) at either the Olympic Games, Youth Olympic Games and/or any World Championships or any other major sporting event shall be entitled to choose to represent their home Affiliated CGA (e.g. Turks and Caicos) at the Commonwealth Games.

#### 4. DISQUALIFICATIONS AND SUSPENSIONS

- **4.1.** A competitor shall not be eligible to represent the Commonwealth Country which enters them if they:
  - a) are currently under disqualification, expulsion, or suspension by the Federation; and/or
  - b) are currently under disqualification, expulsion, or suspension by their respective Affiliated CGA; and/or
  - c) are currently under disqualification, expulsion, or suspension by their respective IF, National Federation, and/or
  - **d)** are currently under disqualification or suspension under the World Anti-Doping Code.

# 5. COMPLIANCE WITH APPLICABLE RULES AND REGULATIONS

- **5.1.** A competitor shall only be eligible to represent the Commonwealth Country which enters them if they:
  - a) Satisfy and comply with all applicable rules and regulations of the Federation; and
  - b) Satisfy and comply their respective IF rules and regulations (including but not limited to, complying with respective IF eligibility rules as applied within each respective edition of the Commonwealth Games Athlete Allocation Systems); and
  - c) Satisfy and comply with the World Anti-Doping Code as applied within the Federation Anti-Doping Standard to ensure that the overriding principles of the Commonwealth Games are observed.
- **5.2.** For the avoidance of doubt, where there is an inconsistency between respective IF Nationality rules and regulations and those of the Commonwealth Games Federation, the Commonwealth Games Federation Bye Law 17 shall prevail.

## 6. TRANSFER OF ALLEGIANCE

6.1. After having established eligibility status under this Byelaw 17 a competitor who has previously represented one Commonwealth Country at a Commonwealth Games may not represent another Commonwealth Country unless they also receive the prior approval of the Federation, the relevant IF and the relevant previously represented Affiliated CGA. For the avoidance of doubt, this Byelaw shall not apply if an individual has represented a Commonwealth Country at a Commonwealth Youth Games. Applications under this Byelaw 17(6) must be submitted to the Executive Board two calendar months before the "final entries deadline"\* for the respective

- Commonwealth Games. Applications must include formal confirmation of the prior approval of the relevant IF and the relevant previously represented Affiliated CGA.
- **6.2.** All applications for transfer of allegiance under Byelaw 17(6) and/or discretionary eligibility dispensation under Byelaw 17(7) including all relevant paperwork and documentation must be submitted no later than two calendar months prior to the published "final entries deadline"\*, as outlined by the respective Organising Committee.

#### 7. DISPENSATIONS

7.1. The Executive Board shall delegate authority to the Governance and Integrity Committee (GIC) who have the power to grant dispensations to Byelaw 17 in exceptional circumstances and to consider any matters relating generally to Byelaw 17. Each application for dispensation under Byelaw 17 shall be considered on its own merits and will not create a precedent for any future applications. Decisions made by GIC are subject to the right of appeal directly to the Executive Board, whose decision shall be final and binding.

\*"final entries deadline" means the final date that an individual athlete may be entered in a particular event(s) for the relevant Commonwealth Games, usually completed via an online entry system. Such date to be communicated for each relevant Commonwealth Games in the Sport Handbook.
